SCOPE OF WORK:

- Drilling of tubewells (Borewells)
- Flushing of existing tubewells (Borewells)
- S, I, T, C of motors, pump sets and control panel boards
- Providing and fixing PVC casing pipe

GENERAL CONDITIONS

- 1. The work shall be carried out as per CPWD specification 2019 Vol-I & II with up-to-date correction slips. For the items which are not covered under CPWD Specifications; B.I.S. specifications shall apply. In this regard the decision of Engineer-in- charge shall be final.
- 2. Unless otherwise specified, the agreement rates for all items of work of the schedule of quantities are for all heights, depths, leads and lifts involved in the execution of work.
- 3. On account of security consideration, there could be some restrictions on the working hours, movement of vehicles for transportation of materials. The contactor shall be bound to follow all such restrictions and adjust the program for execution accordingly, for which nothing extra shell be paid.

- 4. The work shall be carried out in a manner complying in all respects with the requirements of relevant bye laws of the local bodies, Labour Laws, minimum wages act, workmen compensation act and other statutory laws enacted by Central Govt. as well as State Govt.
- 5. No residential accommodation shall be provided to any of the staff engaged by the contractor. The contractor shall not be allowed to erect any temporary set up for staff in the campus.
- 6. All required register will be issued by Engineer-in-Charge/Executive Engineer duly marked in chronological order but the contractor will have to arrange all such registers/stationery etc.

 Nothing extra shall be paid on this account.
- 7. No claim whatsoever for idle labour, additional establishments, costs of hire and labour charges for tools and plants etc. would be entertained under any circumstances.
- 8. For the safety of all labour directly or indirectly employed in the work for the performance of the contractor's part of this agreement, the contractors shall, in addition to the provisions of Safety code and directions of the Engineer-in-charge make all arrangements to provide facility as per the provisions of Indian Standard Specifications (Codes) listed below and nothing extra shall be paid on this account.
 - (a) IS 3696 Part I Safety Code for scaffolds and ladders

- 9. The contractor shall take all precautions to avoid all accidents by exhibiting necessary caution boards and by providing red flags, red lights and barriers. The con- tractor shall be responsible for any accident at the site of work and consequences thereof.
- 10. Contractor shall be fully responsible for any damages caused to govt. property or allotter "property by his or his labor in carrying out the work and shall be rectified by the contractor at his own cost.
- 11. All taxes, Labour Cess etc., as applicable shall be borne by the contractor himself. The contractor shall quote his rates considering all such taxes including GST on works. - 12. Chases, holes & drilling works etc. shall be done using power operated tools in the cost of contract. No extra will be paid for the same.
- 13. The agency shall restore back the premises and other articles provided by the department to the department at the time of closure of the contract.

- 14. In the case of discrepancy between the schedule of quantities, the Specifications and/or the Drawings, the following order of preference shall be observed: -
 - Description of schedule of quantities.
 - Additional specifications and special conditions, if any.
 - Contract clauses of General conditions of contract for Central P.W.D. works.
 - CPWD specifications.
 - Architectural drawings.
 - Indian standards specifications/BIS. (vii) Sound engineering practice. The contractor shall at times during the usual working hours and at all times at which reasonable notices of the intention of the Engineer- in-Charge or other officers as stated above to visit the works shall have been given to the Contractor, either himself be present to receive the orders and instructions or have a responsible Site Engineer duly accredited in writing, to be present for that purpose Senior Officers of NITAP Authorities shall also be inspecting the ongoing work at site at any time with or without prior intimation.
- 17. All the debris during the execution of work shall be cleared every now and then and site shall be kept clear by the contractor at all times.
- 18. The contractor has to make his own arrangements for the watch and ward of the materials and other installations till the installation / work is completely handed over to the department. No extra claim will he entertained on account of this. Any damage to the materials during or under storage will be to the contactors account.

- 3. Prior to detailed evaluation, the Institute will determine the substantial responsiveness of each bid to the tender document. A substantially responsive bid is one which conforms to all the terms and conditions of the bidding/tender document and is without any material defects and deviations. Deviations from, or objections or reservations to critical provisions such as those concerning qualification/eligibility criteria, availability of facilities and amenities as needed, availability of government/statutory approvals and clearances, ready and explicit willingness to accept and honor the terms and conditions of contract etc. will be deemed to be material deviations.
