Instructions for Ph. D (Full-Time/ Part-Time) Admission (Dec 2019 Session)

During 13th -22nd Jan 2020

The selected candidates are required to report in the admission section with all original certificates during **13th -22nd Jan 2020** for admission into the program.

All the candidates after taking admission have to report to the respective Head of the Departments and submit the joining report to the Admission Section duly forwarded by the concerned Head of the Department.

The candidate should submit the following Original certificates/documents:

- i. 10th Marksheet / Certificates as proof of Date of Birth
 - ii. Intermediate/Diploma/10+2 Pass Certificate, Marks sheet
 - iii. UG- Original Degree, Consolidated Marks Memo
 - iv. PG- Original Degree, Consolidated Marks Memo
 - v. GATE/UGC-NET Scorecard (if required),
 - vi. Experience Certificate, Sponsorship Certificate and NOC for Part-Time candidates,
 - vii. Caste Certificate (For SC/ST/Other Backward Classes OBC certificate (Non-Creamy Layer)/EWS certificate issued on or after 01.04.2019 in Govt. of India Format)
 - viii. PwD Certificate
 - ix. Migration and Transfer Certificate.
 - x. Two recent passport size colour photographs.
 - xi. Fee payment receipt
 - xii. Xerox copy of SBI Bank Account Pass book & Aadhar Card.
 - xiii. Two sets of photocopies of the above mention certificates is mandatory. (The candidates are advised to keep sufficient number of photocopies of the original certificates with them.)

 - a. Institute Fee for **Ph. D Programme (Full-Time)** (OPEN, OBC, SC, ST, EWS, PWD candidates) – **Rs. 45,000/-**

b. Institute Fee for **Ph. D Programme (Part-Time)** (OPEN, OBC, SC, ST, EWS, PWD candidates) – **Rs. 60,000/-**

2. Institute fee has to be paid through only “State Bank of India i-collect”. For payment of fee challan use the following link
