### **NOTICE**

**Sub**: Fee remission for I B.Tech. (A.Y.2022-23) students – Reg.

The B.Tech. first year students who have taken admission in the A.Y. 2022-23 through JoSAA/CSAB are requested to submit the applications for claiming the tuition fee remission based on their parent's family income. As per the Government rules the UNRESERVED/OBC students are eligible to get the benefits of fee remission if the family income is as mentioned below.

- i) Most economically backward students (whose family Annual Income below 1 Lakh (maximum allowable Rs.99,999/-)).
- ii) Other economically backward students (whose family Annual Income between 1 lakh to 5 Lakhs (Maximum allowable Rs.4,99,999/-)).

The students are required to submit the below-mentioned documents to the admissions office (Room No:010, Ground Floor, SV PATEL Central Vista) on or before 31<sup>st</sup> Jan 2023 with the following documents obtained from appropriate authorities based on the state to which they belong to.

- 1. Application form for fee remission (prescribed format is attached herewith in Annexure-A),
- 2. Declaration in the non-judicial stamp paper for fee remission with notarized person (prescribed format is attached herewith in Annexure-B).
- 3. **Family income certificate** in the name of father [or mother (in absence of father)]/ guardian (in absence of parents) issued by the competent authority (as prescribed by the respective the State Governments) after **1**<sup>st</sup> **April 2022** for the financial year 2021-22 (i.e., from 1<sup>st</sup> April 2021 to 31<sup>st</sup> March 2022).

#### Note:

- 4. If the "Family income" phrase is not mentioned in the income certificate, individual income certificates in the name of both father and mothers should be submitted if they are working. If mother is housewife/ not-working, students need to submit an income certificate in the name of mother with zero income.
  - If some State Govts are not providing income certificate in the name of mother (house-wife/zero-income) then income certificate in the name of father should only be submitted.
- 5. Death certificate/ certificates along with declaration by the student in the prescribed format (prescribed format is attached in Annexure-C) are required to be submitted if father/ mother/ both the parents are not alive.

- 6. The **issuing authority** of the income certificate shall be according to the enclosed list for each state. Certificate issued by any other authority is not valid.
- 7. The applications received after the due date will not be considered.
- 8. The final list of eligible candidates will be published on Institute website before the registration to the next semester.
