INSTRUCTIONS FOR PAYING THE FEES THROUGH SBI I-COLLECT

- Institute fees required to be paid during 17th – 19th January, 2022 by the selected candidates:
 - Institute fee for **Ph. D. (Full-Time) Programme** (OPEN, OBC, SC, ST, EWS, PWD candidates) – **Rs. 45,000/-**
 - Institute Fee for **Ph. D. (Part-Time) Programme** (OPEN, OBC, SC, ST, EWS, PWD candidates) – **Rs. 60,000/-**
 - Institute Fee for **M.S. (by Research) Programme** (OPEN, OBC, SC, ST, EWS, PWD candidates) – **Rs. 80,000/-**

(Cash/ DD/ Bankers Cheque/ NEFT Transfer or any other mode transactions will not be accepted.)

- Before proceeding to the institute for online reporting, it is requested to pay the required fees online or through the downloaded challan at the nearby SBI branch. The fee payment documents are required to be submitted during physical reporting to the Institute.
- In case of payment through challan, download the challan from the i-collect portal and submit it at any branch of State Bank of India.
- Notice regarding Hostel accommodation and registration will be published on the Institute website by the Hostel's office.
