Sub: -NITANP-SHTL – Providing Paid accommodation to adhoc faculty at Vamsadhara Hall of Residence – Information – Circulated – Regarding.

It is informed you that, with the approval of the competent authority, hostel office is hereby providing paid accommodation to the Adhoc faculty in NIT Andhra Pradesh.

Procedure for availing hostel facility: -

- Accommodation requests should be made through the respective Head of Department (HoD).
- The accommodation will be provided subject to the availability of vacant rooms at Vamsadhara and Ghataprabha hall of residences for male and female faculty members, respectively.
- The accommodation allotment will be done on a first-come, first-served basis only.
- The duration of the accommodation will be linked to the Adhoc faculty member's appointment period, subject to a maximum stay of one academic year.

Facilities:

- Each Adhoc faculty member will be provided a room with a basic amenity such as cupboard and a fan will be provided in each room.
- Accommodation for male Adhoc faculty members will be provided in 4th floor of Vasundhara hall without cots due to insufficient of the same.
- Common areas and facilities like recreation room will be available within the hall.

Rental Charges:

- Adhoc faculty members availing accommodation will be required to pay in advance for every month a nominal monthly maintenance charge i.e. ₹.3,000/- (Rupees Three thousand only) per month, will cover electricity, water, and other shared facilities.

Rules and Regulations:

- All Adhoc faculty members must adhere to the rules and regulations of hostels during their stay.
- Any damage to the accommodation or its facilities caused by the faculty member will be subject to repair charges.
- If any Adhoc faculty involved in any kind student's agitation not only by means of complaint in the hostels will leads to initiate a disciplinary action as per the rules in vogue and also compel the faculty to vacate hostel immediately.

Hence, if Adhoc faculty willing to avail the hostel facility on payment basis duly accepting the above rules and regulations contact the hostel office for room allotment on or before 01-08-2023.
