- a. Bidder must be a proprietor/firm/company and Submit valid PWD of class V/ CPWD of Class V valid registration Certificate for Civil Works.
- b. The bidder should have a valid GST Certificate.
- c. The bidder should submit relevant income tax returns for the concerned years i.e., 2020-21 & 2021-22.
- d. Bidder must have successfully completed the works pertaining to maintenance of civil works with the conditions and value of work/purchase orders defined as under during the period of 01-04-2019 to 30-04-2022.
  - One work of maintenance of civil works costing not less than the amount equal to Rs. 8,00,000/- (Rupees Eight Lakhs only).

OR

 Two works of maintenance of civil works costing not less than the amount equal to Rs.6,00,000/- (Rupees Six Lakhs only).

OR

- Three works of maintenance of civil works costing not less than the amount equal to Rs.4,00,000/- (Rupees Four Lakhs only).
- e. All the payments received against the claim of Work/purchase Orders at Clause (d) above should reflect in Form 26AS at later date. Else the Work/Purchase Order is treated as invalid.
- f. The bidder must have a valid PAN Card and the same should reflect in all financial statements.
- g. Each page of the tender document along with all other submitted documents must be duly signed by the Authorized signatory with Bidder's signature and seal.

#### 5. Placement of Order:

- a. Order will be placed to the empaneled contractor who quoted the highest percentage of discount on ECV of the work.
- b. Depending upon the types of contracts/magnitude of work, the Estate DPC may divide the purchase order among more than one empaneled contractor.
- c. If two or more empaneled contractors offer the same discount on ECV, the order shall be placed to the contractor who obtained higher 'total marks' as per Evaluation Criteria. If the 'total marks' are observed to be same for two or more such empaneled contractors, Estate DPC reserves the right of exercising the choice to place the order to 'empaneled contractor' (among those, who have participated in offering) on a first come first served basis.
